

INVITATION TO APPLY AND TO BID Procurement of Common Electrical Supplies for Bulacan State University (G-2019-20)

The BULACAN STATE UNIVERSITY (BulSU), through its Bids and Awards Committee (BAC) for Goods, Supplies, and Services, invites suppliers/manufacturers/distributors to apply for eligibility and to bid for the hereunder project:

Location : Bulacan State University, City of Malolos, Bulacan

ABC : Php 916,750.00

Delivery Period : Fifteen (15) Calendar Days

Prospective bidders should have an experience of having completed within the last three (3) years a single contract that is similar to the contract to be bid, and whose value, adjusted to current prices using the wholesale consumer price index, must be at least fifty percent (50%) of the approved budget for the contract to be bid. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criterion. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Revised Implementing Rules and Regulations (IRR).

INVITATION TO BID FOR Procurement of Common Electrical Supplies for Bulacan State University (G-2019-20)

- 1. The Bulacan State University (BulSU), through the Income Fund 2019 intends to apply the sum of Nine Hundred Sixteen Thousand Seven Hundred Fifty Pesos Only (\$\mathbb{P}\$ 916,750.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Procurement of Common Electrical Supplies for Bulacan State University (G-2019-20). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Bulacan State University (BulSU) now invites bids for Procurement of Common Electrical Supplies for Bulacan State University (G-2019-20). Delivery of the Goods is required within Fifteen (15) calendar days upon receipt of Notice to Proceed and Purchase Order. Bidders should have completed, within the last three (3) years from the date of submission and receipt of bids (September 23, 2019), a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - In addition, bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 4. Interested bidders may obtain further information from *Bulacan State University* and inspect the Bidding Documents at the address given below during *office hours from 8:00 a.m. to 5:00 p.m., Monday to Friday only (Except on holidays).*
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on September 2, 2019 to September 23, 2019 from the address below and upon payment of

the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Nine Hundred Pesos Only (₱ 900.00)**

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Bulacan State University, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than *September 23, 2019*.

- 6. The *Bulacan State University* will hold a Pre-Bid Conference on *September 10, 2019 (Tuesday), 8:30 a.m.* at the University Hostel 3rd Floor, BAC Conference Room, Bulacan State University, Guinhawa, City of Malolos, Bulacan 3000, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before **September 23, 2019 (Monday), 10:00 a.m.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.
 - Bid opening shall be on *September 23, 2019 (Monday), 10:00 a.m.* at the University Hostel 3rd Floor, BAC Conference Room, Bulacan State University, Guinhawa, City of Malolos, Bulacan 3000. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
- 8. The *Bulacan State University* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
